A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF BRIDGEPORT, NEBRASKA, AUTHORIZING A SPECIAL EVENT CLOSING OF HIGHWAY 385 FOR HOMECOMING PARADE ON SEPTEMBER 23, 2022.

WHEREAS, the City of Bridgeport intends to create a parade route beginning at the intersection of 5th and Main Street to the intersection of 12th and Main Street for the Annual Homecoming Parade on September 23, 2022 from 12:45 P.M. to 3:00 P.M., and

WHEREAS, closure of roadways along the parade route is necessary to relieve the through traffic from the area in the City of Bridgeport, Nebraska on or near the parade route, and provide a safe event for participants and spectators, and;

WHEREAS, Main Street (US-385) roadway from 5th Street to 11th Street is part of the state highway system and is located within the official corporate limits or zoning jurisdiction of the City of Bridgeport, and;

WHEREAS, the City of Bridgeport, while making use of the state highway system for a special event shall have the legal duty to protect the highway property from any damage that may occur arising out of the special event and the state shall not have any such duty during the time the City of Bridgeport is in control of the property as specified in the notice provided pursuant to LB 589/N.R. S §39-1359, and;

WHEREAS, any existing statutory or common law duty of the state to protect the public from damage, injury, or death shall become the duty of the City of Bridgeport while making use of the state highway system for a special event and the state shall not have any such statutory or common law duty during the time the City of Bridgeport is in control of the property as specified in the notice provided pursuant to LB 589/N.R.S. §39-1359, and;

WHEREAS, pursuant to LB 589/N.R.S. §39-1359, thirty (30) days advance written notice of the special event must be provided which specifies the date and time City of Bridgeport will assume control of the identified state highway property, as well as the date and time the City of Bridgeport will relinquish control of such state highway property to the State of Nebraska. In addition, the City of Bridgeport shall to provide beginning and ending locations for the highway closure including sufficient area for the placement of advance warning and/or detour signing, and include sufficient time for the City of Bridgeport to prepare and later clean the property prior to returning possession back to the State of Nebraska, and;

WHEREAS, LB 589/N.R.S. §39-1359 dictates that if a special event includes any portion of the State of Nebraska Highway System, the City of Bridgeport shall, if a claim is made against the State of Nebraska, indemnify, defend, and hold harmless the State of Nebraska from all claims, demands, actions, damages, and liability, including reasonable attorney's fee, that may arise as a result of the special event; and

NOW, THEREFORE, BE IT RESOVLED that said Parade Route and Road Closure referred to hereinabove is hereby adopted. That the governing body of the City of Bridgeport acknowledges and accepts all duties set out in 589/N.R.S. §39-1359, subsection (2) and accepts that the City of Bridgeport shall indemnify, defend, and hold harmless the State of Nebraska from all claims, demands, actions, damages, and liability including reasonable attorney's fees, that may arise as a result of the event and such Parade Route and Road Closure is accepted by the City of Bridgeport and the Mayor and City Clerk are hereby authorized and directed to execute the same on behalf of the Municipality.

Keno Board Member Brad Huck gave an update stating they met for an organizational meeting on September 13 and named Lisa Weborg Chairperson and Brad Huck secretary and would like to have 50K budgeted for disbursement for the 2022-2023 budget year. They would like to change the ordinance from meeting twice a year to once a year and will change a couple items in the guidelines. He stated there is a balance of \$132,594.17 in the Keno Funds and will have 50K available for the application process which will begin October 3 - October 27 and will review applications before the regular city council meeting in November.

26. Dave Smith stated to apply Dust Control on Ethanol Road it will cost approximately \$15,471.95 and can be applied within the next week. Council Member Deines made a motion to apply dust control, seconded by Council Member Wickard. Roll call resulted as follows; Aye: Deines, Rahmig, Clinger, Wickard; Nay: None. Motion carried.

27. Council Member Clinger stated the current contract with Corman Construction regarding the maintenance of Ethanol Road expires September 30, 2022. She visited with Justin Corman, and he is willing to continue with the maintenance but would like to change the hourly rate from \$135.00 to \$150.00 due to the rising cost in fuel. The other change is the city will be responsible for snow removal. Council Member Rahmig made a motion to authorize the mayor to sign the continued maintenance contract with Corman Construction with an hourly rate of \$150.00 and the city is responsible for snow removal, seconded by Council Member Wickard. 28. As per the state and the cities concerns regarding the roads at the sewer lagoons, Perry Nelson reached out to Corman Construction and received a proposal of \$36,750.00 for the repairs. It was discussed to have the roads repaired in this budget year if possible and if he couldn't get to it to have it prepaid. 29. Librarian Melissa Butler asked Council if the library could have the back 24 feet of the two bays of the old fire department for a teen room and for their video/audio equipment. 30. Bob Benton discussed the history of the sewer backups on "L" Street and understands the money has been budgeted but would like to know the date when it will be fixed. Mayor Browne stated they have visited with an engineer and waiting to hear from them on a timeline. Perry Nelson stated they have run the camera through twice as well as the sewer rodder twice from the Senex manhole on L street to the sewer main on 5th Street and stated there is no condition problems, all joints are good and will continue to do maintenance on this line. He felt option 3 would be sufficient with a routine maintenance plan. It was discussed that the engineers report from Mike Ollson stated it was unnecessary to upsize from the 6" line to 5th Street. Kathy Sides spoke and stated she has had sewage backup three times and must check her drains every morning and feels the city needs to change the sewer line and make larger. Council Members stated they have waiting for the report from the engineers which they received the day before the meeting and have stated all options have an 8" line and will discuss which option would be the best option.

At 7:55 p.m., Council Member Clinger made a motion to go into executive session to prevent the needless harm and reputation of an individual, seconded by Council Member Wickard. Roll call resulted as follows; Aye; Clinger, Wickard, Deines, Rahmig; Nay: None Motion carried.

The city will keep it closed and on weekends the deputies on duty can open the gate if needed for residents. His second concern is the crosswalks on main street need to be painted.

Pwcc - Mayor Browne visited with Charlee Wallesen and she stated everything is going well and bumped up the salaries for employees at the center which reflects on the 2022-2023 budget.

Public Works - Perry Nelson discussed the roll off dumpsters behind Riverside Lumber stating we are getting tires, appliances, oil and other items that are not allowed and stated we offered a great service to the residents, but it is being abused. After much discussion, the Mayor entertained a motion to close the dump, Council Member Wickard made the motion, seconded by Council Member Deines. Roll call resulted as follows; Aye: Clinger, Deines, Wickard, Rahmig; Nay: None. Motion carried.

Dave Smith ordered dust control and delivery date is scheduled for the 30th.

Anthony Cannia received the electrical rate study from MEAN with their recommendations concerning the 5% rate hike starting in January 2023 and discussed three options presented to

council. Council Member Wickard would like to review the three different options before going forward with an increase and he and Anthony will have their recommendation to Council for the October meeting.

Council Member Clinger discussed Anthony's proposal concerning Park Foreman Dane Jeffords request to move to the Electrical Department which will create an opening for the Parks Foreman/Maintenance position. Council Member Clinger made a motion to move Dane Jeffords into the Electrical Department and advertise for a full time Parks Foreman/Maintenance position, seconded by Council Member Wickard. Roll call resulted as follows; Aye: Deines, Rahmig, Clinger, Wickard; Nay: None. Motion carried.

Administration - City Clerk Huck stated she received two applications for the PWCC Director Job and Council Member Clinger would like to move forward and start interviews. Council Member Deines will also sit in on the interviews.
