#### VII. REGULAR AGENDA

14. Emergency Items – None

- 15. Mayor Browne discussed his findings regarding paving the NW area of town requested by Darrell Kraupie at the last meeting. Browne visited with PADD and Reed Construction and stated it would have to be engineered and surveyed at a cost in excess of \$1M and to complete the project at a cost in excess of \$5M with the total cost assessed to the city. It was discussed creating paving districts by the residents is the usual route for a paved street. Mayor Browne entertained a motion to start the project request with the total cost being assessed to the city. Seeing none; no action was taken.
- 16. As Chairman of the Planning Commission John Erickson contacted Mark Steer regarding a zoning change request to a piece of his property located on "S" Street and Hwy 385 and stated there is a meeting scheduled for August 24<sup>th</sup>.
- 17. Melissa Butler, Library Director introduced herself and discussed the firehall space next to the library for expansion. She presented a report of the total patrons that use the many activities at the library and would like to do more projects but does not have the space and has had several requests to have a teen room added. Council stated they would like to see a detailed plan before making any decisions.
- 18. Mayor Browne discussed the lack of storage for the Public Works Department to house many of the expensive equipment and Christmas decorations that are currently outside. He stated a storage building was built into this year's budget but had to be taken out due to the expansion of the rural fire hall and the old firehall would be short term storage until a building could be budgeted for the PW Department.
- 19. Bob Benton discussed the sewer manhole on "L" Street and noticed the locates are put in place. The cleaning of the gutters on 4<sup>th</sup> and "L" street still need attention and stated Perry used the bobcat broom but did not work as the broom does not tilt. Council directed public works department to shovel the gutters.

Dust Control is scheduled for the 1<sup>st</sup> and 2<sup>nd</sup> of September and will have to grade all roads before dust control is applied.

20. Michelle Coolige with Twin City Development discussed their proposal to the city and discussed the three different tiers that are available. Currently the city in in tier 1 and will continue to stay in tier 1 for this coming budget year.

21. Rich Eymann with MEAN presented an Advanced Meter Infrastructure (AMI) metering system to read electric and water meters and discussed the pros and cons. The system has the following capabilities: remote disconnect and reconnect, customer loading profile, saves on manpower, is cloud based, alerts for power outages, consistent billing cycles, detect and reduce energy theft while water meters will alert for leak detention. Requires upfront dollars for members and will contract with Itron and NMPP. Currently there are 12 communities that have committed to this project and stated the more communities involved the less the meters will cost. Perry Nelson reminded Council from the last meeting the city is going to have to start replacing the current water meters as they are nearing the end of their life span.

Council Member Deines made a motion to sign a letter of intent, seconded by Council Member Wickard. Roll call resulted as follows; Aye: Clinger, Rahmig, Deines, Wickard; Nay: None. Motion carried.

- 22. Gail Beyer addressed Council requesting 50K of Keno funds to earmark for Phase One of the old swimming hole project to help with the following expenses: clean, rotenone, dredge out sludge, purchase picnic tables, install an ADA accessible composite dock, aerator, engineering/graphics and fencing. Mayor Browne stated to contact the Keno Board and set up a meeting to get their recommendation to present to council at the meeting on September 15<sup>th</sup>.
- 23. Council Member Wickard made a motion to accept the resignation of Lawrence Heinrich effective August 31, 2022, seconded by Council Member Rahmig. Roll call resulted as follows; Aye: Clinger, Deines, Rahmig, Wickard; Nay: None. Motion carried.
- 24. Council Member Wickard made a motion to accept the resignation of Charlee Wallesen effective September 30, 2022, seconded by Council Member Deines. Roll call resulted as follows; Aye: Wickard, Rahmig, Clinger, Deines; Nay: None. Motion carried. Mayor Browne stated to advertise for the Pwcc Director immediately.

*Sheriff:* Cardenas stated they are still short on help and everything else is going well. *PWCC:* Wallesen stated has been slow; received donation money in memory of Jackie Laux and will use it towards the senior room; Youth camp will be next week; sand volleyball pit will be filled in; the cardio room will be getting new carpet.

**Public Works:** Perry Nelson stated the dust control has been ordered; presented lagoon estimate; generator at the nursing home is in and must be rewired correctly; Dan Krentz will be doing some repairs at the library; will get with Library concerning storage at the old fire hall; discussed costs with future infrastructure. Anthony Cannia stated MEAN will be increasing electrical rates by 5% and WAPA will be increasing transmission costs by 16-18%. Mayor Browne and Council Member Wickard gave Anthony Cannia his performance review and recommended him to be appointed as Electric Foreman and an increase in wage. Council Member Wickard made the motion, seconded by Council Member Deines. Roll call resulted as follows; Aye: Wickard, Clinger, Rahmig, Deines; Nay: None. Motion carried.

*Administration:* Received the other half of the ARP funds; Next budget workshop will be August 25<sup>th</sup> at 6:00 p.m. and the next regular meeting will be held September 15<sup>th</sup> at 7:00 p.m.
