# **ORDINANCE NO. 1009**

AN ORDINANCE APPROPRIATING FROM THE FUNDS AND REVENUES OF THE CITY OF BRIDGEPORT, NEBRASKA SUCH SUMS OF MONEY AS HAVE BEEN DEEMED NECESSARY TO DEFRAY ALL NECESSARY EXPENSES AND LIABILITIES OF THE CITY OF BRIDGEPORT, NEBRASKA, FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2024 TO SEPTEMBER 30, 2025, AND LEVYING TAXES FOR SUCH CITY AND FOR SAID FISCAL YEAR FOR CERTAIN OBJECTS AND PURPOSES FOR WHICH SUCH APPROPRIATIONS ARE MADE AND THE AMOUNT APPROPRIATIONS ARE MADE AND THE AMOUNT APPROPRIATE FOR EACH OBJECT AND PURPOSE AND PROVIDING FOR THE CERTIFICATION OF THIS ORDINANCE TO THE COUNTY CLERK OF MORRILL COUNTY, NEBRASKA, AND PRESCRIBING THE TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT.

BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BRIDGEPORT, NEBRASKA.

**Section 1:** That there be and there hereby is appropriated out of the funds and revenue of the City of Bridgeport, Nebraska, the following sums of money deemed necessary to defray all necessary expenses and liabilities of the City of Bridgeport, Nebraska for the fiscal year commencing October 1, 2024, and ending September 30, 2025; and there is hereby levied on each one dollar of actual value of the taxable property within the corporate limits of the City of Bridgeport, Nebraska, for said fiscal year, as shown by the assessment roll for such fiscal year, the amounts set out; the objects for purposes for which such expenditures are to be made, the amount of appropriated, including the amounts due upon legal and valid outstanding bonds against said City and all special assessments and other tax authorized by law are as follows:

City of Bridgeport \$9,386,945

A copy of the budget document shall be forwarded as provided by law to the Auditor of Public Accounts, State Capitol, Lincoln, Nebraska, and to the County Clerk of Morrill County, Nebraska, for use by the levying authority.

**Section 2:** There is hereby appropriated to the respective funds of said City such sums as shall be paid to the County Treasurer of Morrill County, Nebraska, during the ensuring year for taxes and previous fiscal years for such respective funds and there is also appropriated all occupational taxes collected for and during the fiscal year; also unexpected funds in the hands of the City Treasurer at the beginning of the present fiscal year hereby appropriated to be used to defray the expenses or obligations of the City chargeable against said City funds.

**Section 3:** That this ordinance shall be known as the Annual Appropriation Bill and shall be in full force and effect from and after the passage, approval and publication according to law.

**Section 4:** <u>Repeal of Previous Ordinances.</u> Any other ordinance or code section passed and approved prior to passage, approval, and publication or posting of this ordinance and in conflict with its provisions is repealed.

**Section 5:** <u>Effective Date; Publication authorized in pamphlet form.</u> This ordinance shall take effect and be in full force from and after its passage, approval, and publication or posting as required by law.

**Section 6:** <u>Severability.</u> If any portion or provision of this ordinance shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such portion or provision shall not affect any of the remaining provisions of this ordinance, the intention being that the same are severable.

# **RESOLUTION NO. 2024-5**

#### A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF BRIDGEPORT, NEBRASKA SETTING THE PROPERTY TAX REQUEST FOR THE 2024-2025 BUDGET YEAR.

WHEREAS, Nebraska Revised Statute 77-1601.02 provides that the property tax request for the prior year shall be the property tax request for the current year for purposes of the levy set by the County Board of Equalization unless the Governing Body of the City of Bridgeport, Nebraska, passes by a majority vote a resolution or ordinance setting the tax request at a different amount; and

**WHEREAS,** a special public hearing was held as required by law to hear and consider comments concerning the property tax request; and

**WHEREAS**, it is in the best interests of the City of Bridgeport that the property tax request for the current year be a different amount than the property tax request for the prior year.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Bridgeport, Nebraska, by a majority vote, resolves that:

1. The 2024-2025 property tax request be set at \$429,797.42

2. A copy of this resolution be certified and forwarded to the County Clerk on or before September 30, 2024.

# **RESOLUTION NO. 2024-6**

# A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF BRIDGEPORT, NEBRASKA AUTHORIZING ALLOWABLE ONE PERCENT INCREASE IN RESTRICTED FUNDS.

WHEREAS, on April 2, 1998, the Nebraska Legislature passed and approved LB 898 which imposes a two and one half percent lid on certain restricted funds for local governments; and

WHEREAS, Neb. Rev. Stat. Section 13-519.03 (R.R.S. 1943), as amended, allows governmental units to exceed the two and one half percent limit as provided in Neb. Rev. Stat. Section 13-519.01 (R.R.S. 1943), as amended, by up to an additional one percent upon the affirmative vote of at least seventy-five percent of the governing body; and

WHEREAS, to Mayor and City Council of the City of Bridgeport, Nebraska hereby finds and determines that it is in the best interest of the City of Bridgeport that the City of Bridgeport exceed the limit as provided in Neb. Rev. Stat. Section 13-519.01 (R.R.S. 1943), as amended, by an additional one percent as allowed pursuant to Neb. Rev. Stat. Section 13-519.03 (R.R.S. 1943), as amended.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Bridgeport, Nebraska, that the City of Bridgeport exceed the limit as provided in Neb. Rev. Stat. 13-519.01 (R.R.S. 1943), as amended, by an additional one-percent.
