The City Council of the City of Bridgeport, Nebraska, met in regular session at Prairie Winds Community Center, 428 Main Street, Bridgeport, Nebraska, on the 20th day of October 2022, beginning at 7:00 p.m.

WHEREAS, DUE AND LEGAL NOTICE STATING THE TIME, PLACE AND PURPOSE OF A HEARING FOR THE CONSIDERATION OF THE ONE-YEAR AND SIX-YEAR ROAD IMPROVEMENT PROGRAM PLANS UNDER THE HIGHWAY AND STREET IMPROVEMENT PROGRAM, HAS BEEN GIVEN BY PUBLICATION THREE TIMES IN THE BRIDGEPORT NEWS-BLADE, A LEGAL COUNTY NEWSPAPER, AND

WHEREAS, THIS SAME LEGAL NOTICE WAS POSTED IN THREE PUBLIC PLACES IN THE AREA, AND

WHEREAS, THE MAYOR AND THE CITY COUNCIL HAVE CAREFULLY CONSIDERED SUCH PLANS AS PRESENTED AT THE PUBLIC HEARING AND TOOK ACTION, AND DO FIND THAT THE SAME SHOULD BE APPROVED AND ADOPTED,

THEREFORE BE IT RESOLVED, BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BRIDGEPORT, NEBRASKA:

RESOLUTION NO. 2022-14

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF BRIDGEPORT, NEBRASKA TO LEVY SPECIAL ASSESSMENT ON TWO PROPERTIES FROM STREET IMPROVEMENT DISTRICT NO. 2021-1.

BE IT RESOLVED, BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BRIDGEPORT, NEBRASKA:

- 1. The Mayor and Council find and determine: That the Council has heretofore designated this time and place for considering and levying special assessments upon property specially benefited by paving improvements in Street Improvement District (SID) No. 2021-1 to pay the outstanding cost of constructing the same.
- 2. That notice of the time and place of holding of this meeting for said purpose has been duly given to the property owners of record of the properties where assessments are to be levied, by personal service, as provided by statute, with personal service taking place more than four (4) weeks before the time designated for holding this meeting.
- 3. The Mayor and Council have at this session heard all persons who desired to be heard in reference to the special benefits or damages thereto by reason of the construction of said improvements.
- 4. The Mayor and Council find and determine that at the hearing the outstanding assessments have been adjusted and equalized with reference to the benefits resulting from the improvements and have been apportioned among the lots and parcels of land subject to assessment which remain due and owing in proportion to the special benefits accrued to said lots and parcels of land respectively from such improvements; that no lot or parcel of land in said SID has been damaged by the construction of said improvements; that the amounts of benefits specially accruing to each lot and parcel of land ins aid projects by reason of the construction of said paving improvements exceeds the amount assessed against each lot or parcel of land to pay the cost of said improvements. The benefits are equal and uniform and the assessments shown on the schedule hereinafter set out are according to the front footage of the lots or real estate with a balance due and owing within the SID.
- 5. There are hereby levied and assessed upon the several lots and parcels of land in Street Improvement District No. 2021-1 special assessments to pay the cost of constructing said improvements in the amount in dollars and cents set out in the schedule below:

6. Said special assessments shall be a lien on the property on which they are levied from the date of passage of this resolution and shall be certified by the City Clerk to the City Treasurer, County Clerk, and County Treasurer for collection; that the

City Clerk shall also at the time provided by law cause such assessments or the portion thereof then remaining unpaid to be certified to the County Treasurer for entry upon the property tax list; that said assessments shall be payable to and collected by the County Treasurer for remission to the City Treasurer.

7. Said assessments are payable in fifteen (15) equal annual installments, the first of which shall become delinquent on March 1, 2023, a date not less than fifty (50) days from the date of adoption of the resolution, and the remaining installments shall become delinquent the 1st day of March, subsequent to the date of levy and thereafter, in one, two, three, four, five, six, seven, eight, nine, ten, eleven, twelve, thirteen, fourteen, and fifteen years respectively; that each of said installments shall draw interest form the date of the passage of this resolution at the rate of nine per centum (9%) per annum, until the same become delinquent, and after the same become delinquent interest at the rate specified by law for delinquent special assessments for such projects shall be paid thereon; provided all said assessments may be paid at one time on any lot or land within fifty (50) days form the date of levy without interest.

WHEREAS, Resolution No. 2021-06 established (SID) No. 2021-1; and

WHEREAS, Resolution No. 2022-09 set a public hearing for the purpose of levying special assessments on those properties that have not yet paid the costs associated with SID No. 2021-1 and have requested those amounts be levied as a special assessment, and

WHEREAS, Notice of the day, time, and place of the public hearing was personally served upon the effected individuals, and

WHEREAS, Resolution No. 2022-14 assessed a tax levy upon the properties in SID No. 2021-1 with a balance due and owing, and

WHEREAS, Resolution No. 2022-14 specifically stated that taxes were to be collected by the City of Bridgeport Treasurer, and

WHEREAS, Two (2) specific property owners within SID 2021-1 with physical addresses of 1218 T Street and 824 East 14th Street, have requested that said levy be assessed through their county property taxes, and

WHEREAS, According to Resolution 2022-14, such assessed levy is charged an interest rate of 9%, and

WHEREAS, According to Nebraska Revised Statutes 45-104.01, any late payment or payments is charged an interest rate of 14%,

THEREFORE BE IT RESOLVED, BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BRIDGEPORT, NEBRASKA:

<u>Section 1</u>: The City of Bridgeport SID 2021-1 assessed Tax Levy to be collected by the Morrill County Treasurer for the next fifteen years, taxes assessed over the fifteen-year period at a rate of nine percent (9%) annually. VII. REGULAR AGENDA

23. Emergency Items – None

24. Jessica Gregg, Director of Regulatory & Environmental Compliance and Sharon Sequera Senior Regulatory Analyst with Carbon America to discuss potential carbon capture and storage project from the Bridgeport Ethanol plant. This will safely divert CO2 to a secure underground facility benefiting local communities and the environment. A drill rig will be here in a couple months for 3 weeks drilling a test well southwest of town outside city limits, about a mile deep to get some rock and water data. It will take 3 months to process the data collected then at that point will know if there is a project to start the next phase. This project is funded by tax credits and then the tax investor can write off some of their taxes with the federal government.

25. Michelle Coolidge with BB Associates, a community consulting business was present to discuss what she can offer the city in both individual and regional projects as well as a resource to the business community. She will have a fee schedule for the November meeting of what she can do for Bridgeport.

26. Mike Olsen with MC Schaff & Associates was present to discuss the scope of "L" Street with some clarification. In his opinion he felt it is not a capacity issue but more of a maintenance issue and stated everything is flowing well but felt the grease traps from the businesses is potentially causing buildup in one area. After much discussion, it was discussed to design out the whole project as one from 5th street north to Bob Benton property and submit to the state. If at any time council decides to do in phases, they have two years to complete project per state.

27. Teammates member Susanna Batterman addressed the Council about hosting a holiday kickoff event the day after Thanksgiving. The event would consist of a soup supper along with the lighting of the new Christmas lights for Main Street to thank the businesses as well as the residents of the community for all their support and would like approval from Council to work with Electric Foreman Anthony Cannia to coordinate turning on of the lights for the event. Council gave their approval.

28. City Clerk Huck stated the golf course is requesting the balance of their budgeted funds for the 2022-2023 budget year in the amount of \$26,000.00 and wanted direction from Council. Council stated going forward they will need to be on the agenda with their amount of request, their treasurer's report and the reason why.

29. Council Members Wickard and Deines would like to hold off on the 24 x 24 storage area on the north end of the west bays for the library stating they would like to make sure there is enough room for city equipment that needs to be inside. It was discussed there is a library grant that would be paying for the remodel, and it expires in May. Council tabled until next month to make sure all the equipment will fit before a decision is made.

30. Council Member Clinger discussed the tree board ordinance stating it needs to be amended if accepting Dave's resignation. The ordinance states this is a voluntary position with no monetary compensation and gives a list of individuals to be on the board which includes the Street Superintendent. Council Member Deines made a motion to accept the resignation of Dave Smith from the Bridgeport Tree Board and to consult with the tree board to amend the ordinance for the next meeting, seconded by Council Member Wickard. Roll call resulted as follows; Aye: Clinger, Wickard, Deines; Nay: None. Motion carried.

31. Electric Foreman Anthony Cannia stated November 3rd is the deadline if the city wants to proceed with AMI metering. He stated this phase is dependent on how many communities are in which will determine the cost per town. Council Member Wickard made a motion for the Mayor to sign a letter to continue the discussion of AMI metering, seconded by Council Member Deines. Roll call resulted as follows; Aye: Deines, Clinger, Wickard; Nay: None. Motion carried

32. Electric Foreman Anthony Cannia discussed revisiting the Apprentice Program by adding a CDL requirement. After some discussion Council Member Clinger will follow up on how many of the Public Works employees have a CDL and will get back to Council to revisit.

33. Cannia stated the IWorks program will cover the street, sewer, water and maintenance departments at an annual cost of \$5,000.00 and a setup fee of \$8,500.00 which was built into his budget. Council told him to proceed.

Cannia stated it is that time of year to start trimming trees and stated per the ordinance there is no clear standard on how far away to stay away from the primary or secondary lines. He stated OSHA standards state 10 feet clearance on any electric line and his proposal would be 10 feet on primary lines and 5 feet on secondary lines. Cannia will revise the ordinance for the November meeting. Council stated this is a safety issue and for him to trim wherever as needed until the ordinance can be amended.

VIII. REPORTS

34. Department Reports:

Sheriff - Not present

Pwcc - Ryna Giboney stated the floor machine is not working and she ordered a new one with an estimated cost of 10,000.00. The senior room decorations are done with the generous donations of the Jackie Laux Family; received donation money from the Art Bloom family to go towards the baseball programs; the golf simulator hasn't been working for some time; Pepsi cooler went out and parts were ordered. Iasais Mancias will be the new Pwcc Director starting October 31, with a starting salary of 17.00/hour with a 6-month probationary period.

Public Works - Council Member Clinger gave her report on the public works department stating Andy Leisy will be the new Parks Foreman & Maintenance starting October 31, with a starting salary of \$20.00/hour; Dane Jeffords finished the carpet upstairs in the fitness room; Anthony and Dane have been working on the brackets for the flags on main street; working on Christmas light trailer and installing new weatherproof outlets on the poles for the Christmas lights; Perry has been working at the old museum and routine maintenance; Bryan has been doing his routine work at the treatment facility and flushing hydrants; and Dave finished the 1st project on the one and six year road plan fixing P Street. *Administration* - None.
