- 14. Michelle Coolidge discussed the continued work on RWHF, Landbank, Grant Identification, and eligibility for CDBG funding. Council Member Wickard made a motion to extend the hourly contract between BB Associates and the city, seconded by Council Member Deines. Michelle gave an update on the possible Morrill County Landbank and stated Bayard must give 90 days' notice to pull from their current landbank to join the Morrill County Landbank with Broadwater and Bridgeport and it was discussed to draw up a contract to review with all the interested parties to be ready in 90 days.
- 16. Library Board Member Janelle Galvan approached the Council concerning the process and or plan of the Librarian's salaries. The council stated they will be working on performance reviews to be completed by the Council meeting in February. Going forward the Library Board stated they also will be attending the budget meetings.
- 17. Mayor Beyer approached Council at the request of the Public Works dept to have an option of a single membership to the Golf Course or Pwcc. Currently the city employees receive a single membership to Pwcc as part of their benefit package and Council Member Harless stated both entities operate differently as Pwcc receives their entire operating budget from the city and the golf course relies on their memberships to pay wages, repairs, and operations. If the Council decides to give an option, the city will have to amend the budget to compensate the golf course for its memberships. The council took no action and left the benefit package for a single membership to Pwcc and could possibly revisit at budget time.

18. Department Reports:

Public Works: Council Member Clinger stated a water survey was done and will have the reports at the next meeting.

PWCC: Council Member Clinger stated the batting cage is up and fees have been established. There was discussion on the amount they would like to charge, and the council decided since the batting cage was donated to not charge at this time. Clinger also discussed the golf simulator and had some concerns with the alcohol policy. After some discussion it was stated that an adult over the age of 21 must sign the contract before any alcohol can be brought into the room and the center makes sure that all alcohol is gone when they are done renting the simulator room.

Fire Dept: Fire Dept Chief Casey Sides stated the department received a \$10K grant from BNSF and continually applying for more grants if available. Looking at different ways to do their reporting to the state and still working on recruiting and is still a work in progress on cross-training with the different equipment.

Sheriff: Cardenas stated he has one individual at the academy and should be done in April 2024 and still short two deputies. Working on the corner ordinance draft for February meeting. Would like to have one certified individual dedicated to the city ordinances and any school issues.
