

**CITY OF BRIDGEPORT, NEBRASKA  
BUDGET HEARING**

**I. ROUTINE BUSINESS**

The City Council of the City of Bridgeport, Nebraska, met in budget public hearing meeting at Prairie Winds Community Center, 428 Main Street, Bridgeport, Nebraska, on the 11th day of September 2025, beginning at 5:01 p.m.

Following the Pledge of Allegiance to the Flag of the United States of America and Prayer, Mayor Gail Beyer called the meeting to order. Roll call resulted as follows: Present: Carrie Harless, Jeff Nichols, Mark Wickard, Tony McGrath

Staff members present were: None

Mayor Beyer presided, and City Clerk Huck recorded the proceedings.

Mayor Beyer announced, "In accordance with Section 84-1412 of the Nebraska Revised Statutes, the open meetings act is posted at the back of the meeting room for the review of the public."

Notice of the meeting was given in advance thereof by publication in the Bridgeport News Blade on September 4, 2025, the method of notice given, as shown by proof of publication, as shown by attached affidavit of posting as well as posting in the three designated public places; US Post Office, City Office and Prairie Winds Community Center.

Notice was given to the Mayor and all members of the City Council and a copy of their acknowledgement of receipt of notice and agenda is attached to the minutes. Availability of the agenda was communicated in the advance notice and by email notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public.

The Mayor asked if there were any letters of public correspondence for the board. There were none.

The Mayor asked if there are any visitors that would like to speak on an item that is not on the agenda. There were none.

**II. PUBLIC HEARINGS**

6. At 5:03 p.m. Mayor Beyer opened the public hearing on the Budget for Fiscal Year 2025-2026.

All those in attendance desiring to speak regarding the proposed budget were given an opportunity to address the governing body and were given a reasonable amount of time to do so.

Council Member Wickard inquired about the Economic Development Fund, noting that the Ethanol Plant was no longer listed and that the only remaining TIF items are Bomgaars, Panhandle Coop, and Cobblestone. It was also discussed that \$150,000.00 was added to the budget for 911 services, regardless of whether it is used. In the Sewer Fund, the increase for repairs and maintenance is earmarked as the match for the Public Works grant.

There was no increase to the city budget and the city's property tax request is \$417,114.85 out of over a 9.4-million-dollar budget.

Seeing no other comments, Mayor Beyer closed the budget public hearing at 5:14p.m.

7. Council Member Wickard made a motion to accept the Fiscal Year 2025-2026 Budget, with the earmark of the sewer grant match, seconded by Council Member Nichols. Roll Call resulted; Aye: McGrath, Harless, Wickard, Nichols; Nay: None. Motion passed.

8. Council Member Nichols introduced Ordinance No. 1027, AN ORDINANCE APPROPRIATING FROM THE FUNDS AND REVENUES OF THE CITY OF BRIDGEPORT, NEBRASKA SUCH SUMS OF MONEY AS HAVE BEEN DEEMED NECESSARY TO DEFRAY ALL NECESSARY EXPENSES AND LIABILITIES OF THE CITY OF BRIDGEPORT, NEBRASKA, FOR THE FISCAL YEAR

COMMENCING OCTOBER 1, 2025 TO SEPTEMBER 30, 2026, AND LEVYING TAXES FOR SUCH CITY AND FOR SAID FISCAL YEAR FOR CERTAIN OBJECTS AND PURPOSES FOR WHICH SUCH APPROPRIATIONS ARE MADE AND THE AMOUNT APPROPRIATE FOR EACH OBJECT AND PURPOSE AND PROVIDING FOR THE CERTIFICATION OF THIS ORDINANCE TO THE COUNTY CLERK OF MORRILL COUNTY, NEBRASKA, AND PRESCRIBING THE TIME WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH; AND ORDERING THE PUBLICATION OF THE ORDINANCE IN PAMPHLET FORM; AND TO PROVIDE FOR PUBLICATION OR POSTING AS REQUIRED BY LAW, and moved that the statutory rule requiring reading on three different days be suspended, seconded by Council Member Harless. Roll call resulted as follows: Aye: Wickard, Harless, Nichols, McGrath; Nay: None. Motion carried. The motion to suspend the rules was adopted by three-fourths of the Council and the statutory rule was declared suspended for consideration of said ordinance. Ordinance No. 1027 was then read by title and thereafter. Council Member Nichols moved final passage of the ordinance, which motion was seconded by Council Member Harless. The Mayor then stated the question: "Shall Ordinance No. 1027 be passed and adopted?" Roll call resulted as follows: Aye: Nichols, McGrath, Harless, Wickard; Nay: None. Motion carried. The passage and adoption of said ordinance having been concurred in by a majority of all members of the Council, the Mayor declared the ordinance adopted and the Mayor, in the presence of the Council, signed and approved the ordinance and the City Clerk attested to the passage and approval of the same and affixed her signature thereto.

9. Council Member McGrath introduced Resolution 2025-15, and moved that the resolution be adopted, seconded by Council Member Nichols. Roll call resulted as follows: Aye: McGrath, Harless, Nichols, Wickard; Nay: None. Resolution passed.

#### **RESOLUTION NO. 2025-15**

#### **A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF BRIDGEPORT, NEBRASKA SETTING THE PROPERTY TAX REQUEST FOR THE 2025-2026 BUDGET YEAR**

**WHEREAS**, Nebraska Revised Statute 77-1601.02 provides that the property tax request for the prior year shall be the property tax request for the current year for purposes of the levy set by the County Board of Equalization unless the Governing Body of the City of Bridgeport, Nebraska, passes by a majority vote a resolution or ordinance setting the tax request at a different amount; and

**WHEREAS**, a special public hearing was held as required by law to hear and consider comments concerning the property tax request; and

**WHEREAS**, it is in the best interests of the City of Bridgeport that the property tax request for the current year be a different amount than the property tax request for the prior year.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of the City of Bridgeport, Nebraska, by a majority vote, resolves that:

1. The 2025-2026 property tax request be set at \$417,114.85
2. A copy of this resolution be certified and forwarded to the County Clerk on or before September 30, 2025.






### III. ADJOURNMENT
