I. ROUTINE BUSINESS

The City Council of the City of Bridgeport, Nebraska, met in budget workshop #3 meeting at Prairie Winds Community Center, 428 Main Street, Bridgeport, Nebraska, on the 15th day of September 2022, beginning at 5:33 P.M.

Following the Pledge of Allegiance to the Flag of the United States of America, Mayor Charlie Browne called the meeting to order. Roll call resulted as follows: Present: Mark Wickard, Angie Clinger, Will Deines, Dean Rahmig

Mayor Browne presided, and City Clerk Huck recorded the proceedings.

- 7. Discussed "L" Street sewer line with three different proposals addressing the size of the sewer line connecting to the main. Perry Nelson stated the camera has been through the manhole on "L" Street twice all the way to the 10" main on 5^{th} Street and is clear.

Bob's concern is from manhole ("L" Street) to manhole (5th Street) and asked if there is enough money in the proposed budget for 2022-2023.

Council discussed the Golf Course request of 104K and reduced their request to 36K and the remainder of 14K will go in miscellaneous and 54K in sewer.

Total Budget for 2022-2023 is \$8,741,141.00 up 3% from last year; Property Tax Request, \$407,084.00 no change from last year; and Valuation, \$90,472,126.00 no change from last year. Leaves a cash reserve of 40% of budget, so cash reserve is projected at 2.7 million after the end of 2023.
