## CITY OF BRIDGEPORT, NEBRASKA BUDGET WORKSHOP \#3

## I. ROUTINE BUSINESS

The City Council of the City of Bridgeport, Nebraska, met in budget workshop \#3 meeting at Prairie Winds Community Center, 428 Main Street, Bridgeport, Nebraska, on the 15 th day of September 2022, beginning at 5:33 P.M.

Following the Pledge of Allegiance to the Flag of the United States of America, Mayor Charlie Browne called the meeting to order. Roll call resulted as follows: Present: Mark Wickard, Angie Clinger, Will Deines, Dean Rahmig

Staff members present were: Anthony Cannia, Perry Nelson, Dave Smith, Dane Jeffords, Melissa Butler

Mayor Browne presided, and City Clerk Huck recorded the proceedings.
Mayor Browne announced, "In accordance with Section 84-1412 of the Nebraska Revised Statutes, the open meetings act is posted at the back of the meeting room for the review of the public."

Notice was given to the Mayor and all members of the City Council and a copy of their acknowledgement of receipt of notice and agenda is attached to the minutes. Availability of the agenda was communicated in the advance notice and by email notice to the Mayor and Council of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the public.

The Mayor asked if there were any letters of public correspondence for the board. There were none.

The Mayor asked if there are any visitors that would like to speak on an item that is not on the agenda. Bob Benton asked council if there was money built into the budget in the sewer department for "L" Street.

## II. REGULAR AGENDA

## 6. Emergency Items - None

7. Discussed "L" Street sewer line with three different proposals addressing the size of the sewer line connecting to the main. Perry Nelson stated the camera has been through the manhole on "L" Street twice all the way to the 10 " main on $5^{\text {th }}$ Street and is clear.

Bob's concern is from manhole ("L" Street) to manhole ( $5^{\text {th }}$ Street) and asked if there is enough money in the proposed budget for 2022-2023.

Council discussed the Golf Course request of 104 K and reduced their request to 36 K and the remainder of 14 K will go in miscellaneous and 54 K in sewer.

Total Budget for 2022-2023 is $\$ 8,741,141.00$ up $3 \%$ from last year; Property Tax Request, $\$ 407,084.00$ no change from last year; and Valuation, $\$ 90,472,126.00$ no change from last year. Leaves a cash reserve of $40 \%$ of budget, so cash reserve is projected at 2.7 million after the end of 2023.

## III. ADJOURNMENT

There being no other business, the Mayor entertained a motion to adjourn the meeting. Council Member Rahmig made a motion to adjourn the meeting at 6:40 p.m., seconded by Council Member Clinger. Roll call resulted as follows: Aye: Clinger, Deines, Wickard, Rahmig Nay: None. Meeting Adjourned.
