## I. ROUTINE BUSINESS

Mr. Plummer also discussed cyber-attacks and discussed adding to the city insurance policy and will have some quotes after receiving the cyber application.
- 8. Went through the remainder of the departments to discuss their budget requests. The city will be doing a rate study on the electric due to rising costs from our supplier. Other discussions included the contract with the Sheriff Department.

Our next budget workshop will be September 15<sup>th</sup> at 5:30 p.m. with the final budget numbers to be presented.
