I. ROUTINE BUSINESS

The City Council of the City of Bridgeport, Nebraska, met in regular session at Prairie Winds Community Center, 428 Main Street, Bridgeport, Nebraska, on the 12th day of May 2022, beginning at 7:00 p.m.

Following the Pledge of Allegiance to the Flag of the United States of America, Mayor Charlie Browne called the meeting to order. Roll call resulted as follows: Present: Mark Wickard, Angie Clinger, Dean Rahmig, Will Deines.

RESOLUTION 2022-03

A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF BRIDGEPORT, NEBRASKA TO APPOINT REPRESENTATION FOR THE CITY TO COMMITTEES AND COUNCILS DEALING WITH THE CITY'S ENERGY UTILITY.

WHEREAS, it is the desire that the City of Bridgeport remain involved with our wholesale supplier of electricity to ensure our voice is heard, and

WHEREAS, the City will be represented with our best interests discussed and debated with representation,

WHEREAS, the City of Bridgeport, State of Nebraska, is a party to the Electrical Resources Pooling Agreement and, pursuant to the terms of such Agreement, it is the responsibility of the City of Bridgeport to designate a representative and alternate representative to the Municipal Energy Agency of Nebraska Management Committee provided for under the terms of said Agreement.

WHEREAS, the City of Bridgeport, State of Nebraska, is a party to the Interlocal Agreement creating the Public Alliance for Community Energy and, pursuant to the terms of said Agreement, it is the responsibility of the City to designate a representative of the City of Bridgeport to the Public Alliance for Community Energy Board of Directors provided for under the terms of said Agreement.

NOW THEREFORE, BE IT RESOLVED, BY THE MAYOR AND CITY COUNCIL OF THE CITY OF BRIDGEPORT, STATE OF NEBRASKA:

Section 1: Director and Alternate Director to MEAN BOARD OF DIRECTORS

This is to certify that the City Council of the City of Bridgeport, State of Nebraska duly appointed Council Member Mark Wickard, to serve as director* to represent the City of Bridgeport on the Board of Directors of the Municipal Energy Agency of Nebraska. The appointment will run for a term of three (3) years with the powers and duties incident to such office. This certificate is issued in compliance with the Municipal Cooperative Financing Act contained in the Nebraska Revised Statutes §18-2401 et. seq. (1987).

This is to certify that the City Council of the City of Bridgeport, State of Nebraska duly appointed Lawrence Heinrich, to serve as alternate director* to represent the City of Bridgeport on the Board of Directors of the Municipal Energy Agency of Nebraska. The appointment will run for a term of three (3) years with the powers and duties incident to such office. This certificate is issued in compliance with the Municipal Cooperative Financing Act contained in the Nebraska Revised Statutes §18-2401 et. seq. (1987).

**Upon the adoption of an ordinance or passage of a resolution as provided in this section, the mayor, in the case of a city, the chairperson of the board of trustees, in the case of a village, or the chairperson of the governing body, of each of the proposed participating municipalities, with the approval of the respective governing body, shall appoint a director who shall be an elector of the municipality for which he or she acts as director.*

Section 2: Representative and Alternate Representative to MEAN MANAGEMENT COMMITTEE

1. The City Clerk is hereby directed to give written notice to the Municipal Energy Agency of Nebraska of the appointment of Council Member Mark Wickard, as representative to said MEAN Management Committee.
2. The City Clerk is hereby directed to give written notice to the Municipal Energy Agency of Nebraska of the appointment of Lawrence Heinrich as alternate representative to said MEAN Management Committee.

Section 3: Representative and/or Alternate Representative to NMPP MEMBERS' COUNCIL

1. Such City be and hereby is a member of the Nebraska Municipal Power Pool.
2. The City Council of the City of Bridgeport, State of Nebraska, does hereby appoint Council Member Mark Wickard as the representative of the City of Bridgeport, State of Nebraska, to the Members' Council of the Nebraska Municipal Power Pool.
3. The City Council of the City of Bridgeport, State of Nebraska, does hereby appoint Lawrence Heinrich, as the alternate representative* of the City of Bridgeport, State of Nebraska, to the Members' Council of the Nebraska Municipal Power Pool.

**Pursuant to Article V of the Amended and Restated Bylaws of the Nebraska Municipal Power Pool, "Any person appointed as Representative or Alternate Representative shall be a resident of the area receiving services from the appointing Member."*

Section 4: Director and Alternate Director to ACE BOARD OF DIRECTORS

1. The City Clerk is hereby directed to give written notice to the Public Alliance for Community Energy of the appointment of Council Member Mark Wickard, as the City's representative to said Board of Directors.
2. The City Clerk is hereby directed to give written notice to the Public Alliance for Community Energy of the appointment of Lawrence Heinrich, as the City's alternate representative to said Board of Directors.

Section 5: If any portion or provision of this resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such portion or provision shall not affect any of the remaining provisions of this Resolution, the intention being that the same are severable.

13. Emergency Items – None.

14. Andrew Plummer presented a dividend check of approximately \$36,000.00 from Employers Mutual Company and stated it is based on the safety performance of the overall municipality and fire department programs within EMC. This marks the 19th time in the past 25 years the company was able to issue a dividend with this being the largest.

15. Kirk Fellhoelter was present to ask permission to close N Street east of the community center during Camp Clarke days on June 4th for the annual Platte Valley Bank Beef Cookoff and beer garden (provided by Panhandle Coop). The money raised goes towards the cattlemen's foundation and to promote beef in the area. Council Member Wickard made a motion to allow the closing of N Street, seconded by Council Member Rahmig. 16. Pioneer Trails Museum Director Billie Mitchell presented council a quote in the amount of \$2,292.35 for security cameras/alarm system which would be interfaced with the sheriff's department and a monthly monitoring fee of \$32.95 per month. She also discussed upgrading the lighting system to LED lights in the amount of approximately \$1,300 - \$1,500. Council Member Wickard made a motion to accept the bid for the alarm system and to replace the lighting at the museum with LED lights, seconded by Council Member Deines. 17. PWD Larry Heinrich presented updated job descriptions for the Public Works Personnel from 2010 job descriptions for council for adoption. Council tabled to next month to have more time to review.

18. Department Reports:

Sheriff: Part time ordinance enforcement officer will be starting to monitor yards and everything else is going well.

Pwcc: Charlee Wallesen stated they will be cleaning and filling the pool next week for the May 30th opening. Parks Foreman Dane Jeffords has been helping with maintenance; the heating/air duct work has been cleaned and came in under the quote estimate from Gering Valley Plumbing & Heating.

Public Works: Larry contacted four entities to provide electrical support during emergencies: Chimney Rock Public Power, City of Gering, City of Alliance and Wheatbelt with his recommendation choosing Chimney Rock Public Power; looking into re-graveling 3rd and 4th street; and would like to use some of the ARPA money for lagoon repairs. Mayor Browne directed Larry to order a generator for the nursing home using the ARPA funds.

Administration: City Clerk Huck stated Senex Foundation Director Mitch Friedman contacted her to close the Skyview Resident Trust account and stated this was an account that was left open during the transition to Senex Foundation to cover any resident fees.
