V. PUBLIC HEARINGS

At 7:03 pm, Mayor Browne opened the public hearing for public comment on the Planning Commission's recommendation to rezone Lots 11, 12, 13, 14, Block 7, Nicholas Addition (Kuskie Oil) from the current zoning of "R2" Residential to "HC" Commercial District for a potential RV park.

Gary Oltmann presented a petition with 22 signatures of the property owners who reside within 300 feet of the Kuskie Oil property. He stated he is against the RV Park and asked if there will be onsite staff, an age limit on campers and length of stay.

One resident strongly opposed both an RV park and trailers as it has been a continual eyesore with three vacant trailers which are uninhabitable with animals residing in them. Another was opposed to an RV Park, filling stations or motels but does not mind trailers. While one stated by bringing in an RV park it can also bring in pedophiles. Another resident stated there are many out of towners at the state lakes breaking into campers and complained about the sheriff's department not patrolling and stated, "You couldn't' protect the state lakes so how are you going to protect the residents?"

There being no other comments from the public, Mayor Browne closed the public hearing at 7:53 p.m.

- 20. Emergency Items None
- 21. Vince Ryan with Gardner, Loutzenhiser & Ryan P.C. presented the 2019-2020 audit and stated the Nursing Home accounts have been rectified from the previous year and the city as whole was under budget by \$800,000.00 and historically the city is in good shape financially.
- 22. Lorraine Mann updated the council on the money raising events and future events scheduled in March for the fireman's auxiliary. Her concerns now are what is going on with the fire hall and stated there have been some incidents that happened recently which prevented the emergency vehicles from getting to the scene in a timely manner because of a train blocking the tracks. She is very concerned for all the first responders getting to the scene of the accident and stated she understands there has been land purchased for a fire hall and does the city have an idea when it will be built and where.
- 23. Council Member Rahmig responded on the future of the fire hall and stated the land has been purchased and the building demolished. There have been questions about the propane/fertilizer plant and granary plant being too close to the land. He would like to see a new fire hall this year and stated there is \$150,000.00 earmarked in the current budget for the hall. He has received a bid from Gingerich for a building 80' x 100' with 16-foot sidewalls, cement, insulated, finished on inside, concrete floor, 9 bays, four steel entry doors and windows at a cost of \$391.700.00. Mayor Browne stated at the March meeting there will be decisions made on the fire hall.
- 24. Mayor Browne is requesting bids for the 2021 mowing contract and will contact Jim Vassos to review the bid spec list before it is published. Bids will be opened at the March 11 meeting.

25. Rick Edigar & Ryan Keller were present to discuss the current Keno Contract which is set to expire February 17, 2022. Lucky One LLC, Andy Clarkson is the current owner and has agreed to sell the company to Ryan Keller. Ryan addressed the council and asked if there were any questions and to consider the current agreement with a 5-year agreement. Mayor Browne stated to have City Attorney Rodak look over the contract and put it on the March 11th meeting.

- a. Sheriff Cardenas stated they hired a new certified deputy as they had to let the one go and everything else is going well. Council Member Floyd commended his department for patrolling the state lakes even though that is not the department's jurisdiction and appreciates their department for taking care of the city.

- d. City Clerk Huck gave examples of how the current occupation tax fee permit is received when holding special events at Pwcc and would like to restructure the way the ordinance is written. Council Member Wickard will work with her on revising the ordinance.
