Golf Course – Jeff Neely and Christopher Plummer presented their wish list for an increase in the annual budget and sinking fund and added machine repair; tree removals and sprinkler repairs in the amount of \$104K

Parks Dept – Install new fence on the west basketball court and purchase a rototiller attachment; turf in batting cage; gravel for parking lot

Museum – Will keep budget the same at last year but would like to see an increase in salaries

City Attorney stated the wish list is at 2.5% increase and is a good start and will continue with a second budget workshop to finish out the departments.
