VII. REGULAR AGENDA

12. Emergency Items – None

13. Robin Stuart was present to apply for handicap parking at 921 Main Street on north side of 10th Street. Mayor Browne's major concern is wanting the curb cut done before painting the curb, as it is dangerous and a hazard for a wheelchair or walker to get over the curb. Robin Stuart stated the curb will be cut when the weather allows, and she will bring new plans back to council.

After much discussion on liability issues, where to paint the handicap curb, and wanting the curb cut done before painting Council Member Rahmig made a motion to grant a blue handicap parking from the south door of 921 Main Street going east roughly the length of a van, seconded by Council Member Deines. Roll call resulted as follows; Aye: Rahmig, Deines, Wickard; Nay: None. Motion carried.

Mayor Browne also discussed a concerned citizen with a mobility issue in the 700 block across from the high school who would like to have a handicap parking in front of his home to prevent the high school students from blocking his steps to his property. It was discussed that this is in a residential area and there is nothing the city can do.

14. Vince Ryan with Gardner, Loutzenhiser & Ryan P.C. presented the 2020-2021 audit and stated they did not see any issues and continue to have the bond reserve accounts. No concerns with the audit reports and stated every department either maintained or increased in cash reserves. He discussed the restricted assets, the tax abatement (TIF) funds, the general obligation bonds and the city came in under budget by 381K. Historically he stated the city is setting pretty good. Council Member Wickard made a motion to accept the auditor's report, seconded by Council Member Rahmig. Roll call resulted as follows; Aye: Deines, Rahmig, Wickard.

- c. Mayor Browne stated the city buildings need a building maintenance person. Currently, Perry Nelson has been doing the maintenance at Pwcc which is taking away from the mechanic repairs of the city vehicles and equipment. Mayor Browne suggested to

council to either hire a part time maintenance for Pwcc or hire a full-time maintenance to take care of all city buildings. He stated he visited with the PWD Heinrich and Nelson and both stated there would be plenty of work for a full-time maintenance person. Other suggestions included contracting a handyman when needed. Council stated they would like to table to get more information and talk with PWD Heinrich before making any decisions.

d. City Clerk Huck stated she received a resignation letter from Deputy Clerk Hoxworth effective Feb 9, 2022 and will be starting the process to find a replacement.
