OLD BUSINESS

The city council has one more budget meeting before the budget approval. Butler does not foresee any issues with the budget the library has put forth for the upcoming fiscal year.

Galvan brought information on a used book buying program called Decluttr. Butler will get started on the process with Friends of the Library members.

Marva Hutchinson will be returning to the library to take over the weekly Storytime until such time as we have found a new employee. She will also be working some Saturdays. Butler will be advertising for the position again once the new budget has been approved.

The Friends have approved and signed the contract with the architect to get started on the renovation. Megan Hayward will have plans for the FoL by the end of the year. At that time, we can start looking further at capital grants. Millette asked for information about the firehall kitchen/meeting room which was initially promised to the library. The city council has given this space to the Girls Scouts to run as a meeting room for rent, for the city. The library is allowed to use this room whenever the Scouts do not already have a meeting planned. The city council has made it clear the library will likely not be given anymore space in the firehall for which to expand.

NEW BUSINESS
